

Submission Re. 2019 North Canterbury Fish and Game Fishing Regulations Review

With regard to the above review I wish to submit that the following amendments be made to the existing regulations for the reasons given:

That the following methods have no place in a freshwater recreational sports fishing environment (emphasis on the term "sport") that should correctly be based on the physical and mental fish hunting skills of the individual angler.

- (1) The use of "down-riggers" to get baits/lures to deeper levels than would otherwise be difficult or unachievable by other permitted and authorized fishing tackle methods.
- (2) With an anticipatory eye to the future; the use of drones or any other aerial or aquatic mechanical device to deliver an angler's line to the water.
- (3) The use of any electronic or mechanical means of detecting or locating the position of fish (fish-finders etc.) except for fishery management purposes.

Recommended change to "open season" for Lake Ellesmere.

With the population in the Ellesmere district increasing rapidly, this huge lake (which is currently rarely sports fished at any time year) could become a great local angling asset particularly if the water quality improves.

(4) That Lake Ellesmere be open all year for sports fishing (as is the case for Lake Forsythe) except from a defined distance from the mouths of important seasonal spawning rivers and streams.



Dear North canterbury fish & Game.

I could go on for a very long time as I have many points and from my own personal experience recomendations but ill keep it simple and shorter.

- Please go with as many recomendations as posible from the expert DFO report as listed on the salmon committee page. Recommendations for Addressing Declines in Chinook Salmon
 Abundance in New Zealand
 David Willis
 Hatchery Section Head
 Salmonid Enhancement Program
 Department of Fisheries and Oceans Canada.
- 2. Season catch limit of wild sea run salmon. Please finally make a season limit with the limit been a maximum of 4 wild salmon retained. As per Steve Terrys report dated June 2018 this will save 24 or 26% of returning adult salmon on the rakaia and Waimakariri. The new limit amount only effects a minimum of 2% of salmon anglers who still take just as many as the other 98% combined total approx and this report shows the its the same % of anglers year after bloody year taking too many fish when we now need the escapement. I would also be happy if it was 5 or 6 salmon but at this stage we need those extra 24% of spawners at minimum. Should have really been made qty 20 then 10 salmon many years ago. As i have been present with an honary F&G ranger all my life up to 2014 and hearing my father ask the question off how many salmon have you caught this year i know what some people use to indicate. Forget the age old how is it going to be managed /compliance issues, your mate or friends makes it compliance when you tell him how many salmon you caught etc.
- 3. Even with a new total salmon season retain limit e g. Qty 4 salmon. Next new rule to be the following. can only kill or catch and release a qty of two wild salmon on any given day and then you must stop salmon fishing.
- 4. Single hook rule. I think single with barb is ok and this would also give people a chance to use all there treble hooks up as can cut off two of the three shanks from the treble. I have been and fished in Canada many times but not since 2010 and at this stage it was single hook and you could squash the barb down with pliers and was all good to use as long as when running the barb over the top of your finger nail the squashed barb didnt scratch it. If moved to no barb at all many anglers who are lucky to hook a salmon will loose there first salmon of the season i guarantee it maybe even the second one also and many will be very angry.
- 4. I totally object to closing any further salmon fishable areas of north canterbury rivers. I can speak for the rakaia and Waimakariri rivers as i fish them regularly and know the white post western areas but not on the other rivers. The western zone allready closes one quarter or more of these rivers to salmon fishing. People like to fish different parts of these rivers and as i fish by a jet boat or by car during the season if the new cut off area is any gorge bridge and up i see this causing big problems as jet boating fishing people will move down river and annoy shore anglers very much more you dont see them out when they are in any gorge. I also have other reasons but im keeping it short.
- 5. From experience if any part of the river needs to be closed to salmon fishing its the mouth and tidal. Hence also why canada also has a tidal fishing waters license which is different to the seperate fresh water license both cost different amounts.
- 6. Could introduce the purchase of a wild salmon retaining license which is extra in canada if you wish to keep and kill a salmon. \$25 or something. Then if people really kicked up a fuss about there been a total limit sure ok you can by a second one for \$50 for a further 4 salmon.
- 7. And or Could introduce a salmon habitat and enhancement stamp say like \$20 or \$25 like the hunting license which could go directly to and for salmon and not be taxed by national fish and game.
- 8. People like to fish for salmon during different parts of the season, maybe due to timing, work, family, sports, etc, so i really wouldnt reduce the season length of time.
- 9. Was known in 1990 any hatchery operations after glenariffe etc would need big money spent. we now need real big money for a recovery just cant relie on escapement make the price increase but please make sure in doing so national fish and game dont get to tax it or much of a cut. Unless they are wishing to contribute \$100,000 minimum towards ncfg hatchery releases every year from now.

- 10. Trout fishing in western zone salmon rivers. method of fishing should only be fly fishing. Or spin with weight/bubble &fly. During the months of 1st january to 28th February. I have photos of trout fishing people holding caught western zone salmon and i can confirm they do target salmon at times in closed waters.
- 11. No catch & release wild salmon is to leave the water for a photo taking and held up out of the water by hand for photos.
- 12. Please apply for fishery regulations prosecution time been extended as at a later date video evidence or photos can be found but is to late to charge for a fishery regulations conviction. Currently only must be charged within a one year period? I have found photos and videos of people doing so who are illegally fishing or targeting salmon and or killing salmon in closed western zone waters but they cant be currently charged and this also applies for people jet boating spawning waters.
- 13. Please note. If fishery angler catch regulations and fishery closure is your only course of action taken due to it been the easy option which it is and none of the other habitat / environmentale / compliance and other important problems etc are taken seriously after these new regulations changes, please keep in mind you will have one pissed off Dougal Matravers kicking up a big stink in a few years as i have seen and had enough. I would also be very interested in the seeing the confidential agreement with trust power and seeing if trust power has fulfilled this agreement and what the agreement is exactly. Knowing the effects of the lake coleridge scheme and reading many old documents over the last 6 years i see many points of interest and not full disclosure of full facts by other than fish and game including untruth and not full correct facts been given in expert witness statements at ecan hearings and old documented studies not been used which could have which prove all we thought that was effecting and really hurting salmon in there river life stages is true etc.

I understand from a post on the Complete Angler Face Book page that this review is taking place with submissions due by 5pm Friday the 10th May,

Firstly, I would like to ask why all fishing licence holders have not been informed of this review and given the opportunity to make submissions?

Secondly, I would like to suggest the following changes to current regulations concerning the high-country lakes.

- Having visited Lake Self for the first time in about 40 years under perfect conditions I was very disappointed at the lack of visible trout that I feel can not have been helped by the now allowable use of spinning gear and a winter season. Can we surely not give the trout a rest between May to October and revert to fly fishing only which now only seems to apply to a minimal number of lakes? I have seen comments on You Tube from other anglers and have spoken to others who also state that fish numbers are low in this lake. The introduction of rainbow trout has given this fishery a new dimension and I would prefer to fish for rainbow trout any day.
- If spinning gear is to be allowed, then single hooks would allow more likelihood of catch & release.
- I cannot believe that trolling is also now allowed in Lake Taylor and this is surely not appropriate for a fishery that once was fly only with a large number of trout which also now appears to be a state of serious decline regarding fish numbers like Lake Selfe.
- Spinning gear is allowed on Lakes where it is inappropriate because of their small size and should be restricted to larger Lakes only

Salmon Run Deterioration

Dear Sir/Madam,

I am primarily interested in fly fishing for trout but I do intend to try Salmon fishing at some stage. I have however read with disappointment the accounts of the ever declining numbers of salmon and it tends to put me off this part of the fishing experience. What is of particular disappointment is the reported incredibly disproportionate distribution of catch rate across all people fishing for salmon.

I have a very simple solution that your Council might like to consider.

I was fortunate a number of years ago (1993) to experience a fishing trip in the Northern parts of Canada. On buying a license you also purchase tags, each one of which entitles you to one fish. I bought four. As you can see by the enclosed samples – I did not enjoy a high degree of success with catching Salmon. On catching the fish you must thread one of these through the gills and mouth and woe is you if you are caught with a Salmon without the tag! (I did by the way have an excellent time catching and releasing Arctic Grayling on my six weight fly rod and that to me was more fun by far than catching any Salmon)

It seems to me that this may be a simple system to introduce here. Perhaps up to four could be issued automatically with the purchase of the license but then I suggest a reasonably substantial fee should be charged for every additional tag to those people intent on "harvesting" the fishery. At around say \$20/KG for farmed salmon I would think it would not be unreasonable to charge \$50 per additional tag. A modest 5KG wild salmon would then still be half the supermarket rate for farmed salmon. Not that I think a beautiful wild salmon should be priced anyway but it seems that is a reality.

Perhaps some people will spend the money and harvest as they wish but at least the funds can be returned to assist with the good work you folks do in maintaining our fishing environment for those who are out there primarily for the sheer pleasure of the fishing experience.

The best outcome though would be the financial disincentive for the few who plunder the fishery, resulting then in a gradual recovery in the number of wild salmon in our rivers.



NEW ZEALND SALMON ANGLERS POLICY RE SEA RUN SALMON

Rationale: It is vital that a sea salmon fishery be maintained in New Zealand.

Points of view:

- Angler catch is not the cause of the drop in salmon numbers.
- Stream clearing would improve spawning areas.
- Ova planting can enhance fish numbers.
- The NZSAA "alevinator" has been a useful way in increasing hatch percentages
- Hatcheries are another aspect that can assist in maintaining the fishery.
- Impose a closed season from May 1 to September 30.
- A voluntary fish a day limit.
- Increase the amount of water in the rivers by curtailing irrigation.
- Climate change has altered the rainfall and river flows so irrigation/farming must adjust accordingly.
- Healthy rivers are a benefit to all.

Measures and actions:

- Increase efforts to improve spawning stream habitat.
- Prevent sediment and pollution runoff from urban and rural areas.

- Effective monitoring and compliance of fish screens on all water takes with abatement and prosecution for non compliance.

Confusion around 3.3 page 28 which states: 'No Licence holder shall fish for salmon in the following waters: All rivers from 1 May to 30 Sep'.

Page 25/26 States under 'Eastern Zone rivers', Open season, 1May to 30Sep the following areas as:

- *Ashley river downstream of Ashley gorge road bridge to state highway one.

Dear Councillors

I would like the North Canterbury Council to give serious consideration to the possibility of providing additional protection - in terms particularly of catch limits - for some of our back country fisheries. In particular I would like you to give some thought to the possible introduction of catch and release on some of the most vulnerable fisheries. I have in mind fisheries such as Lake Marymere with its unique Loch Leven strain of trophy fish but relatively poor spawning conditions. It is a serious concern that unthinking anglers could conceivably kill two such trophy trout per day. Whilst I'm aware that one would have to be either a very skilful or a very lucky fisher to do that, I still believe that there is a serious case for making Marymere catch and release only.

In the past NC Fish and Game has stated that catch and release is problematic to regulate yet the 'nil' limit for the winter fishery on the Ashley is but catch and release by another name.

Some of the smaller back country streams that, at certain times of the season, also hold trophy fish might also benefit from such further protection.

500 Metre Distances at River/ Stream Mouths

Has North Canterbury Fish & Game Council & Central South Island Fish & Game considered **Erecting White Poles** either side of river/stream mouths to determine the **500 Metre Distances**. it would certainly stop any misconception about fishing areas for Licenced & unlicenced anglers.

Refer:- Sports Fishing Regulations (South Island)
2018 -19 Sports Fishing Regulations "Guide Booklet" **PAGE 8 (D)**"Fresh Water" Means; **Point (D) Distance of 500 metres at river/stream mouths.**

The 2018-2019 Fish & Game Signs Reads:

All Anglers fishing with gear suitable for catching sports fish Require a Sports Fishing Licence unless fishing in the sea more than 500 metres away from the river mouth.

A Possible /Suitable Solution (to make River / Stream mouths easier to control) All Anglers Lure or spin fishing for sports fish **Must Be Licenced** fishing inside the white poled 500 metre areas.

Fisher People **UNLICENCED** fishing inside the white poled 500 metre areas **have to bait fish only.**

Any Sports Fish caught on a "Bait Assembly" or "Foul Hooked" must be returned to the water immediately inside the 500 metre distances or move outside the 500 metre pole distance down the beach To Lure / Spin or Bait Fish in the Sea.

Regarding the review.

It is important to show the public that we are doing our bit to manage the fishery.

The most telling factor is that we don't actually know how many fish are being caught.

The majority of the fish are being caught by experienced relentless fishers.

I know of groups that will exclusively occupy and fish a site and fish it around the clock every day for weeks. When the fish arrive their group descends on the location to extract as many fish as possible

These fishers take a disproportionate amount of the stock.

Daily bag limits are not enough to limit their effort.

A salmon tag- zip tie should have to be attached to any salmon taken then we would have better understanding of the numbers caught.

Unused tags could be returned at the end of the season Simple barcodes could be used to track/allocate tags

Numbered Salmon tags could be issued on request to a licence with a limit of 4 tags for the season

Measures to make the fish harder to catch ie single hooks etc will only discourage the 90% of fishers (Including juniors)

that actually live in hope of catching a salmon one day.

Hi

I was wonder if we could have included again a reference to included boat fishing / trolling close to shore base fisherman and that the boats keep at least 100 m out (casting range) of fisherman fishing from the shore.

As over the last couple of years its not been included or mentioned and since that time there has been a number of issues regarding boat within 50 m of fishermen fishing from the shore around a number of our lakes. Lake Coleridge in august 2018 had an issue with a fishing competition being run where a number of boats were very close around the mouth of the Harper river. When ask to give us room we were told there is no regulation to do move out to the 100 m.

So we would appreciate if this 100 m rule as either a regulation or in the code of conduct to help land base fisherman and boats fisherman get along and reduce any further conflict that has happened in the past. There are also alot of new visitors now using our fisheries and do not know alot about the codes of conduct here in NZ

Hope you can consider this request and are able to include it in the next review of the fishing licences.

Public Submission for Regulation change to Kaiapoi River

I am writing on behalf of the majority of Kaiapoi Salmon Anglers.

The request is to have salmon fishing allowed for the month of April in the Kaiapoi River, upstream from the Main Road bridge.

It is highly respected by local fisherman that upstream of the Kaiapoi North School Bridge is not fished anyway. Even a change in the cut-off point would be acceptable as indicated on map below.

Two options would be the School Bridge (A) or the Smiths/Charles Street Corner (B).

Another option could be via a white post half way down the straight (C) between these areas?

Due to unusual conditions in the 2018 season, salmon fishing has to date been fairly non existent with only a few caught in December, virtually none in January and February, and just a mere few caught to date in March in the Kaiapoi River.

In addition to the extreme hot summer, we have also had to contend with many floods to date, tree trimming that have seen messy trimmings floating up and down the river for weeks and more recently, tons of weeds filling the river from recent cleanups.

A recent survey of one "hot-spot" last week showed it was still running at 19 degrees, 600mm of sediment on the bottom and no fish being present in the selected area (the Cam River point)

This has made the river fairly well un-fishable most of the time, in addition to an overall lack of fish being in the local rivers.


The Kaiapoi River is a convenient place to fish for local residents and is mainly fished by the elderly fishermen. Because of inaccessibility to most other spots in the area at the more productive low tides (knee deep mud downstream from the Main Road Bridge, plus it is full of "snags") it is really dangerous to fish there as the age range of fisherman is generally over 65 years of age with several in their 70's, 80's and one in their mid-nineties. Because of their age and physical disabilities, they are unable to make the walk to the other good fishing spots in the Waimakariri River, namely: Stewarts Gully, McIntosh Rocks and the River Mouth.

As they look forward to the salmon season every year, this year they are being unfairly penalised by not being able to fish at a time the salmon should be present as they have paid their licence fees for many years and this year most of them have not had a single bite. They really should be able to have the opportunity of catching at least one feed.

Kaiapoi River fishing over the past few years has declined and during the last two seasons, only one fish has been caught on average every twelve days among the twenty odd fisherman than regularly fish there.

I trust you can give this submission careful consideration
