3. Welcome By The Chairman

Cr Isitt opened the meeting by thanking and then inviting the attendees to stay on for the Council meeting which was to follow the AGM.

4. Minutes from the Previous Annual General Meeting Dated 14th December 2016

Under No 6. Noted that the year should read 15/16 and not 14/15 regarding the presentation of the Annual Report.

5. Summary of 2016/17 Issues and Achievements

R Cullinane welcomed everyone to the meeting by stating that staff would not give full presentations but would summarise current issues happening in the Region.

a. High Country Lakes

T Hawker gave background to the current closures of six lakes in the region –

- 3 weeks ago trout were found with red spots and rash;
- F&G notified MPI immediately of possibility of new disease;
- F&G closed Lakes Grasmere and Sarah;
- fish found sent to MPI for testing, with full results hopefully prior to Christmas;
- all Waimakariri Lakes were closed as a precaution after Hawdon fish found;

General feeling was the problem could be weather related with oxygen levels in lakes low. There was hope the lakes would reopen prior to Christmas. There had also been good feedback on communications on this matter to stakeholders as well.

b. Environment

S Pearson reported briefly on the following:

- the establishment of better partnerships with ECAN;
- better communication process regarding non notified consents;
- compliance monitoring established special protocols on stock exclusion issues, processes were

being developed to more accurately check fish screens;

- Rakaia River a group has been established to try to get more data from ECAN scientists;
- 2 nominees were received for the Working With Nature Awards;
- Hurunui/Waiau An agreement between ECan and the Hurunui Waiau Zone Committee has seen new minimum flows for Amuri Irrigation Company (in the HWRRP Plan) deferred for the last five years, while they focused on nutrient discharge reductions. In the upcoming "targeted plan change", Fish and Game is pushing strongly for the new minimum flows to now apply to all water permit holders, which would lead to the Amuri Irrigation water take consents being.

6. Presentation of the 2016/17 Annual Report

R Cullinane reported a financial deficit of \$255,700 that was made up of hatchery over expenditure, depreciation, employee related costs and some approved use of reserves. Licence sales for the year were down on the previous year. Levies payable to NZC increased slightly on reduced income. This review will assist with determining future funding.

A hatchery review was being undertaken by Cawthron Institute to better determine funding levels.

A Strong was thanked for all his work on the project also.

9. General Business

In answer to any updates from the recently held Salmon Symposium, R Cosgrove stated there would be an update from the Symposium before Christmas. Cr Cumberpatch stated that NZC supported the Salmon Sub-committee being formed as the problems were seen as a national not local project.
