# Kai Iwi Lakes application to release trout

The manager elaborated on the recent meeting and withdrawal of the application, strongly advising against release of trout without support of iwi.

The Chairman apologised for being unable to attend the meeting and praised the Managers conduct in the face of a difficult situation, stating the Manager had taken the correct course of action. The Chairman suggested the council take no further action on the trout release application for now and set it aside to focus on the Dwarf Inanga population and ecology of the Kai Iwi lakes.

The Manager advised his intention to involve Fish & Game in two collaborative workstreams – a focus group regarding the health of the Kai Iwi lakes (Te Roroa, Te Kuihi, Northland Regional Council, Department of Conservation), and a group to monitor the success of the Dune Lake Galaxiid translocation to lake Riu near Waipoua Forest ((Te Roroa, Te Kuihi, Department of Conservation). Cr. Allen suggested galaxiid be translocated to other lakes and dams to see if they could become viable populations with trout present.

- Agree to \$153 Fish licence
- Agree to \$113 Game licence
- Support sea run salmon \$5 licence fee
- Do not support the \$5 charge to NZ residents fishing in Designated Waters outside their "home" region
- Agree to \$40/day charge to non-resident anglers fishing designated waters
