Mr Teal called for nominations for the position of Chairman.

8. <u>Conflicts of Interest</u>

A list was available for viewing of the existing declarations of Conflicts of Interest. No new conflicts of interest were declared.

9. <u>Minutes of Previous Meeting of 13 October 2015</u>

Councillor Shortis requested that a comment attributed to him in the draft minutes be removed and after a brief discussion it was moved that: *the amended Minutes of the Wellington Fish & Game Council of 13*

October 2015 be approved as a true and correct record of the proceedings of that meeting.

10. <u>Matters Arising</u>

Mr Teal provided a review of the Action List regarding:

- Walking Access Commission Review ten years from inception review will start in 2018
- Weekly Fishing Report Assessment the 'opened' log was for readers who had opened the file
- Curriculum Material Development for Fish in Schools this had been progressed with a supplier providing a cost estimate;

- Lake Wairarapa Wetland Treaty Settlement; covered in Lake Wairarapa Update
- Funding Duddings Lake Promotion underwritten by Fish & Game by grant funding should cover most of shortfall.
- Mallard Research Fund and Next Steps

11. <u>NZ Council Business</u>

Councillor Morris confirmed that most recent NZ Council meeting had seen several new appointees to the NZ Council.

Councillor Morris noted that the national licence sales report had indicated a decline in fish licence sales for the early part of the season compared to 2014/15 especially in the Wellington and Auckland/Waikato regions (~ -10%). NZ Council considered that the promotion of licence sales was primarily a regional function and some tweaking of regional budgets may be required. Councillor Morris indicated that the licence sales graphs (2013/14, 2014/15, and 2015/16 to date) provided by Mr Teal were very useful in putting licence sales into perspective.

Councillor Morris gave an overview of RM cases including the implementation of provisions in Horizons Regional Counciløs Regional Plan. It was also considered prudent to follow up on successful cases to ensure provisions had been correctly implemented.

Councillor Johnson arrived at 3.20pm

Councillor Tannock attended the NZ Council meeting held in Hamilton, and gave a background on the Game Bird Habitat Trust activities and possible extra income opportunities. This included the option to review the \$2 gamebird habitat stamp royalty to \$3. He considered that the Trust was turning away projects that were worthwhile as there were not enough funding to go beyond current lists of projects. He considered this was further compounded by the practice of stamp collecting and items such as artwork were less popular which had been an important income stream. After further discussion it was considered that the Wellington F&GC would consider a remit for the 2017 season to the Minister before the May NZ Council meeting. Councillor Tannock would seek to obtain relevant facts and figures for discussion at the April meeting of Wellington F&GC.

Councillor Morris noted that Warwick Lampp from Electionz.com had provided an overview of the recent F&G regional elections including ensuring integrity of information of candidate profiles.

Councillor Morris informed Council that NZ F&GC had withdrawn from Land And Water Forum prior to its recent report provided to the Minister for the Environment. Councillor Morris noted that there would be opportunities to support candidates in the upcoming Local Government Elections in 2016 that promoted better outcomes for Fish & Game interests.

Councillor Morris provided a brief summary of the field trip around the Waikato lakes and a brief overview of the work undertaken on the Mallard Research Project.

Councillor Morris confirm that the NZ Council had undertaken a review of its governance policies which will be of interest to regional F&GCs.

Councillor Morris reported on North Canterbury F&GCøs proposals to fund the continuance of the Fish In Schools programme and indicated that he had voted against the motion due to the way NCF&GC were wanting to use their reserves. There were also issues regarding intellectual property which may provide an indeterminate result for other regional Fish & Game Councils.

It was then moved

That the report presented by Councillor Morris relating to the NZ Fish & Game Council meeting on 20-22 November 2015 be received Simon Muckley/Andy Tannock

12. <u>Recommendations for the 2016 Game Season</u> <u>Mallard:</u>

Mr Pilkington gave a brief overview of the summary provided in the staff report regarding increasing numbers seen in the April 2015 mallard transect count. Mr Teal gave a brief overview of the supporting information contained in the email survey conducted which noted hunter preferences for options for any restrictions on bag limit or season length ó should they be deemed necessary. Mr Pilkington provided further information on the forecast El Nino event and potential effect on rainfall.

Councillor Tannock noted that he had received anecdotal feedback that confirmed a good breeding season in the Manawatu and Wairarapa areas.

After further discussion it was prudent to make a preliminary recommendation that would be reconsidered in January following a review of climate and rainfall data.

It was then moved that

The mallard season conditions for the 2016 game season be a bag limit of eight birds per hunter per day, and season length of eight weeks Chris OgMeara/Jim Cook With an amendment moved

That these recommendations be subject to review of severity of drought conditions at the end of January

The amendment was accepted by the original proposers and the motion was put

The mallard season conditions for the 2016 game season be a bag limit of eight birds per hunter per day, and season length of eight weeks, subject to review of severity of drought conditions at the end of January

It was noted that the alternative option to be considered in January would be an eight week season length and six bird limit.

Paradise Shelduck:

It was noted that the conditions for paradise shelduck is subject to the January moult counts, and would be considered by telephone conference in late January.

NZ Shoveler:

After brief discussion, it was moved that

The current shoveler limit be retained at two birds per day for the waterfowl hunting season

Strato Cotsilinis/Marc Flaws Carried

Pukeko:

After discussion it was noted that pukeko distribution is not even throughout the region ó being locally common and more sparse in some localised areas also.

It was then moved

That the current limit of five birds per day for the Wellington region be retained

<u>Red-Legged Partridge</u> After discussion it was moved that *The conditions for red-legged partridge remain the same as 2015 season*

Pheasant:

After discussion it was moved that

The main season conditions for pheasant remain the same <u>Andrew Morris/ Marc Flaws</u> Carried

The merits of allowing Game Preserves (Upland Game Properties with Special Conditions) to provide hunting in April prior to the main start of the season was discussed. Mr Cook indicated his potential conflict of interest in these discussions and did not participate in the discussion. It was moved that

any requests for an early start to the game season for Upland Game Properties with Special Conditions in April 2017 would be declined Andy Tannock/Andrew Morris Carried

California Quail:

After brief discussion it was moved that

There be no change to the season conditions for California quail for the 2016 game season

Andrew Morris/Dan Waechter Carried

A letter from licenceholder Reg Cull was considered. He outlined his concern about the practice of groups to feed out before and during the season, thereby taking birds away from public area hunting opportunities. He was seeking a fairer and ethical manner regarding the practice.

Discussion ensued on the following points:

- supplementary food was seen as important to reduce migration and starvation;
- pond feeding had been legal for 35+ years;
- acknowledged that some operations were relatively large in amount,
- most hunters appeared happy with the status quo.
- If the option of stopping feeding during the season was pursued would it be too hard to enforce.
- Had there been a noticeable increase in numbers of ponds being fed

Councillor Tannock suggested that Mr Culløs letter be received and indicate to Mr Cull that it had been discussed at length.

Mr Culløs second point in his letter referred to a loyal card or licence option. It was considered that Wellington F&G Council didnøt have the ability to directly influence this option. Councillor Johnson requested that the statistics of hunters ages be presented to see if a discount materially affects revenue. Licenceholder Paul Browne noted that there would be support amongst hunters for a loyalty senior licence category. It was then moved that

A letter be sent to NZ F&G Council indicating licenceholder demand for a senior loyal licence for game hunting and that this should be considered after research on how many would be eligible and potential revenue impact

Councillor Tannock suggested a letter be sent to Mr Cull indicating that this option would be actively looked at.

The issue of potentially restricting multi-shot shotguns from 5 to 3 was discussed, with the Council retaining its existing position of not allowing magazine extensions, rather than magazine restrictions.

It was then moved that

All other season conditions to remain the same

The email survey highlighted that hunters would like to see actions that contributed to habitat improvement and predator control to improve mallard numbers. Licenceholder Paul Browne noted that the habitat values at Boggy Pond and Wairio Wetlands at the Wairarapa sites had improved hunting opportunities. Councillor Tannock noted the importance of predator control and noted figures from the Swamp Comp promoted by the Waterfowl Enhancement Trust had gone from 750 tails 2 years ago to 1155 1 year ago to nearly 2000 tails this year ó indicating enthusiasm by hunters to trap predators.

13. Junior Novice Angling/Hunting Programme Update

Mr Teal provided an overview of the Fish In Schools programme and a summary provided by Hamish Carnachan of the four schools involved in 2015.

Councillor Scott indicated that Manawatu Freshwater Anglers potentially may have a small surplus from the Childrenøs Fish Out Day to be in a position to get some environmental learning items that could contribute to the Fish in Schools programme. Mr Teal gave an overview of a proposal to get a formal curriculum material developed. Mr Carnachan had obtained an indicative quote from a supplier and there had been interest from NZ F&GC and Southland F&G in contributing to costs in the order of \$15,000 but required another region to meet about \$2,500 shortfall. Eric Neumann sought clarification on the details of the outcomes from the supplier (nature of material ó e.g. digital focus), given that this was a modest cost. It was agreed to support the concept in principle and pursue if the outcomes were appropriate for the contribution.

Mr Teal also noted that he had sent a letter to North Canterbury F&GC when they were seeking funding for the continuation of their Fish In Schools programme ó which requested more formal outputs that could be used in other regions.

14. Mallard Research Update

Mr Teal noted that the mallard research project was progressing well this year which up to 60 hens being radio tagged in Southland and Waikato ergions. He reported that there were no significant issues with project management that had arisen the previous year. Councillor Tannock provided an update from the field trip held at the NZ Council meeting in the Waikato, and noted that nesting appeared to be late this year and that duckling mortality was similar in both regions. He expressed his concern that it was coming to the end of the current field work and would prefer to see a programme of research continue ó rather than other freshwater projects being given priority. He thought there needed to be direction from the researchers and Managers to define work going forward and that this should be expressed to NZ Council and other regions. He considered that hunters would support an investment back in the resource through research. Councillor Johnson considered that more rigorous appraisal need to be done to ensure enough data had been collected to confirm cessation of project and then provide direction for future research.

15. <u>Lake Wairarapa Update</u>

16. <u>Wairarapa Water Storage Report</u>

Mr Teal confirmed that Fish & Game had withdrawn from the Stakeholders Advisory Group and that we would be seeking updates with the regional council directly.

18. <u>Management Report 1 October – 30 November 2015</u>

Mr Teal noted that the NZ Council had agreed that the õextraö funds generated from non-resident licence sales be ring fenced for projects in the region where sales were generated. This use of funds still needed to be defined but the principle was to use it on projects relating to backcountry fisheries. Mr Carnachan had indicated some options such as the use of trail cameras to assess use of sites within Forest Park boundary. After further discussion it was moved that

Wellington Fish & Game Council establish a dedicated reserve derived for non-resident licence sales "additional income" to be used on backcountry projects.

19. <u>Fishing Licence Report</u>

Mr Teal expressed his concern regarding licence sales compared to last year and outlined the promotion activities that would be taken up till Christmas period. He noted that while lower than last year it was only slightly lower than two years ago ó with potential reasons being speculated as poor weather in October and November, economic climate, and the start of the season coinciding with Rugby World Cup. Any further action would be reviewed following the February Council meeting

After brief discussion it was moved that

The Fish Licence Sales report as at 27 November 2015 be received. <u>Andrew Morris/Brad Johnson</u> Carried

Conservation Board chairman Don Adams noted that there was a potential review regarding issues around whitebaiting activities which he brought to the Counciløs attention.

Licenceholders Paul Browne, Mark Hickey, and Adrian Hickey, and Conservation Board chairman Don Adams left the meeting at 5.20pm.

21. <u>Correspondence and Media</u>

The Childrenøs Fish Out Day at Duddingøs Lake was successful with a huge effort from Manawatu Freshwater Angler Club members and staff - Steve Pilkington in particular. Over 400 fish were caught over the two day period.

Mr Teal noted that the Rangitaane iwi settlement for the Manawatu had been completed which included DOC areas and Tangimoana Forest, and there needed to be dialogue with the iwi post settlement to explore common management goals.

Brief discussion ensued on correspondence and media after which it was then moved that
