R Gabrielsson stated that currently there were limited resources, both budget/staffing and the issue of access would require more time and effort to be put into it going forward.

2.1 CHANGES TO THE 2021/22 FISHING REGULATIONS

R Gabrielsson stated the following minor adjustments were required to be made in the 2021/22 Fishing Regulations. Reasons for the adjustments are:

- 1. Heathcote River accidentally opened up spawning areas to all year round angling;
- 2. Use of Motorised Boats on Some High Country Lakes the amendment is to bring F&G regulations to align with the Selwyn District Council's District Plan.



Regulations Changes for the 2021/22 Fishing Season

1. Heathcote River

Amend the Anglers Notice to read the following season length: Heathcote River below Colombo Street bridge - open all year; and Heathcote River above Colombo Street Bridge - 1 October to 30 April

2. The Use of Motorised Boats on Some High Country Lakes

Introduce a new "Note" under "additional requirements", that prohibits the use of motorised boats on Lakes Blackwater, Catherine, Evelyn Georgina, Grasmere, Hawdon, Henrietta, Ida, Letitia, Lillian, Marymere, Moana Rua/Pearson, Red Lakes, Rubicon, Sarah, Selfe or Vagabonds Inn, is limited to one of the following uses; Emergency search and rescue work; or law enforcement.

2.2 ENDING THE NATIONAL SEA RUN SALMON COMMITTEE

On establishment, one of the NSRSC's main goals was to initiate the process for a season limit bag to manage salmon harvest which has been now approved by Cabinet. An adaptive management strategy has since been developed to sustainably manage the east coast salmon fishery. In discussion it was identified that further policies needed to be developed to pertain only to NCFG & CSIFG.

Cr Musson stated the NSRSC was not involved in running of the salmon fishery in both regions and that a certain level of governance was required to follow through to update the 10 year management plan.



Future of the Sea Run Salmon Committee

That the NCFG Council recommend and that a letter be sent to NZC asking that the National Sea Run Salmon Committee be disbanded and that the governance of the sea-run salmon fishery be undertaken collaboratively by the South Island salmon regions.

- 4. Feedback was required by 25th June 2021 on the three to five year implementation of the Review changes and amalgamations clearly articulate concerns of managers influence in decision
