#### 6.1 General Business

#### REGULATIONS

Cr Musson requested clarification on the salmon take for the Rakaia River as information was conflicting. R Gabrielsson acknowledge staff had made mistakes, and confirmed the Gazette had been updated and that he would send Cr Musson a link to this information. He also stated that there would be a revision of the layout to look at simplifying the regulations layout for next season.

#### **REX GIBSON - Reflection on Three Years as a Councillor**

Cr Gibson thanked the Council for the experience. He commended Cr Strong on an incredible job at tackling the challenges head on over past three years as Chairman. NCFG very fortunate to have been able to have G Nahkies experience and guidance. Re-elected councillors to Council was an endorsement of work well done. He suggested the need for a finance committee to oversee finances and talk to finance reports. He spoke on the relationship with Mana Whenua and how it has progressed and stated this needed to be kept up. Suggested to consider a Treaty Hui with Network Waitangi for the new Council.

#### **GRAEME NAHKIES**

Thanked outgoing councillors for their efforts over the past three years and greeted the new Councillors. He thanked Cr Strong for his tireless efforts over a very difficult period for NCFG. He

urged council to be bold, environment degradation to name a cause. He stated the funding issue for NCFG would continue to be a problem and advised there was still a lot of work on this. There also unfinished work regarding Council's governance.

R Gibson and G Nahkies both outlined the criticism being meatered to past Council's surrounding financial outcomes and the lack of funding being given to the NCFG region.

#### **SNAKE CREEK**

Cr Gibson congratulated E Arthur Moore on her Snake Creek Report. Council discussed the good and bad outcomes from this Project, including the lack of tangible benefits to the sports fishery.
